Dear Parent/Carer

In March 2024, a team of inspectors from Education Scotland visited Canberra Primary School and Nursery Class. During our visit, we talked to parents/carers and children and worked closely with the headteacher and staff.

The inspection team found the following strengths in the school and nursery's work.

- The strong, authentic leadership of the headteacher and her highly inclusive approach which has created a culture of respect and belonging for all. She is passionate about developing leadership capacities in others which is evident in all aspects of school life.
- The nurturing, caring and respectful relationships which support children's sense of belonging very well. This leads to a calm, purposeful learning environment in the school, in which children are eager to learn. In the nursery, children are motivated and engage very well with the range of natural and open-ended resources which supports their creativity and curiosity very well.
- The wellbeing of children sits at the centre of the work of the school and nursery. The effective whole school approach to supporting and developing wellbeing is leading to improved outcomes for children across the school and nursery.
- The headteacher empowers staff and children to lead change. Staff engage in highly relevant professional learning and undertake a wide range of leadership roles effectively. Children relish the opportunities given to them to influence changes in their school. As a result, there is a strong sense of wanting to improve together.
- Children's attainment in literacy and numeracy is very good. Children, supported by the reading buddies initiative, make very good progress in reading.

The following areas for improvement were identified and discussed with the headteacher and a representative from South Lanarkshire Council.

- In the school, develop further staff's understanding of high-quality learning, teaching and assessment. This should lead to more effective and stimulating approaches to learning, set at the right level of difficulty, for all children.
- Across the school and nursery, refine approaches to checking children's progress, including in curriculum areas other than literacy and numeracy. This would enable staff to use data more effectively to demonstrate progress, and the impact of additional supports, across all learning.

We gathered evidence to enable us to evaluate the school's work using four quality indicators from [How good is our school? \(4th edition\)](#) and [How good is our early learning and childcare?](#) Quality indicators help schools, local authorities and inspectors to judge what is working well and what needs to be improved. Following the inspection of each school, the Scottish Government gathers details of our evaluations to keep track of how well Scottish schools are doing.
